Annual Report of the Secretary, CySI for the year 2021-22.

Respected Members,

We are very happy to present the Annual Report for the year 2021-2022 before you. The office Bearers and the Executive Committee Members, while assuming office on 5th September 2021, decided unanimously that all matters pertaining to the activities of the Cyber Society of India, be it big or small, should be brought to the knowledge of all the EC Members through WhatsApp group named 14 of CySI EC 2021-23 and only after due approval of the EC such activities should be approved. The most important objective set forth was to conduct a greater number of Cyber awareness programmes. We, the office bearers and the Executive Committee Members are very proud to place it on record that with the best co-operation and co-ordination amongst ourselves we could successfully conduct many such programmes in spite of the impact of COVID 19. We have immense pleasure in furnishing the details of activities and our achievements during the financial year 2021-2022.

Evidently, COVID 19 restricted the real activities of Cyber Society of India involving physical presence of members. During this financial year our society organized three Kanininar Series and one programme involving physical presence of members on 16.04.2022. CYSI Members have delivered Cyber awareness sessions organised by Rotaract club of Madras School of Social Work and another programme by AVAR. CYSI Members have also participated in the TV programmes to spread cybercrime awareness. AGM was held and, alongside, election was also conducted wherein all the Members were elected unanimously. Speakers participated in the programme were felicitated by Tamil Parattu kavithai 1500 copies of which were printed out of the funds contributed by the EC Members and a well-wisher Mr. R.Muthunalliappan, a former police officer and distributed to the public at free of cost in the 45th Chennai Book Fair 2022. Digital Booklets were also published in WhatsApp. 30 Life Members were inducted and one Student Chapter was inaugurated at Vedavyasa, Institute of Technology, Malappuram-Dt.. CYSI Website was upgraded.

During the EC meeting, silence was observed for one minute in remembrance and honour of the services of those who passed away recently - Mr. R.Padmanabhan FCA, Auditor and Mr. Shanker Kumar, former Secretary. Mr. R Vievkanandan, Joint Secretary was felicitated for inducting Netizens totalling as many as 55 as Life members of CySI. A legal wing was constituted, and Mr P. Raman was nominated as coordinator of CySI Legal Wing. Court Case: The Civil Suit filed by Mr.S.N.Ravichandran questioning the show cause notice issued on him by the Secretary before the Additional District Munsiff Court in OS NO 186/ 2020 against Cyber Society of India is being defended well and the discharge petition filed by us has been posted on 19.10.2022 for orders. We have conducted 4 EC Meetings apart from one AGM. Facilitating ease of remembrance programme posters are incorporated and YouTube link for those programmes are also provided. As usual, auditor report is also incorporated. We assure to continue to serve the Society for the remaining period with your support.

Cyber Society of India organised a seminar on cyber crime at Dr. MGR Janaki College of Arts & Science for Women. According to a press release, the aim of the programme was to create awareness about online fraudsters and cyber crimes.

N. Karthikeyan, the society's president welcomed the gathering. In his inaugural address, Amaraesh Pujari, Director General of Police, Cyber Crime Division - Chennai, gave an overview of the extent of cyber crimes occurring in the country. He mentioned about the helpline number 1930 which attends to cyber crimes. He said that if a victim calls 1930 within five minutes of the occurrence of the crime the probability to recover the lost money is more. He also suggested that banks can play a role in creating awareness about the helpline number by sending free SMS to their customers.

D. Shanmuga Priya, Superintendent of Police, Cyber Crimes, spoke about prevention of online crimes.

Balu Swaminathan, former president of the society, briefed the laws pertaining to cyber crimes.

Further, victims of online frauds shared their experiences. It ranged from frauds in sales platforms, due to use of unverified mobile apps, phishing, impersonation on social platforms, SIM swapping or cloning, scams through QR codes, frauds using screen sharing, ATM card skimming and many more, adds the release.

 Delivering the Inaugural Address, Mr. Amaraesh Pujari, Director General of Police, Cyber Crime Division, Chennai provided an overview of the extent of loss inflicted due to cyber-crime in our country and pointed out that more than Rs. 12 crores is lost with damages suffered by more than 80 websites every day in India. He reiterated the current facility for recovering the loss due to cyber frauds wherein there is an assured

possibility to recover the lost money if the victims can dial 1930 within 5 minutes of the occurrence. He also stressed the need for strengthening the laws relating to cyber-crimes and urged the government to take the needful policy decision towards that end. As a useful tip for the clients, he suggested to the banks to send free SMS alerting on the existence of the 1930 free dialling facility which can prove a boon for those falling victims to cyber

frauds. Mr. Amaraesh Pujari also recommended to the government to consider including lessons in schools which can bring about awareness on cyber-crimes as a means for safeguarding the future generation from cyber fraudsters. Tmt. D. Shanmuga Priya IPS, Superintendent of Police, Cyber Crimes spoke on prevention and detection of online fraudsters by Cyber Crime Division and Mr. Karthikeyan, Cyber Advocate spoke on the laws relating to cyber-crimes.
