- 3) CySI eligible Voters Electoral roll to exercise their votes will be Published in the www.cysi.in . As per **CySI Bye Law Clause 12 (ii) para 2** “Any life member in good standing will be eligible to contest for membership in Executive Committee after satisfactory completion of at least two years of active membership and regular attendance in the Annual General meetings, as a life member as verified and approved by the EC and the Election Officer appointed for the purpose.” are eligible to contest in the Election. **Clause 11. Enrolment of Members: E. (I)** All fresh memberships will be effective from the date of receipt of relevant fee if any by the society or from the date of approval by the Board of Directors whichever is earlier.

- **Commencement of Nomination:** 03.07.2023 Monday
- **Deadline for filing nomination:** 09.07.2023 Sunday
- **Last date for withdrawal:** 13.07.2023 Thursday
- **Publication of Contestants:** 17.07.2023 Monday
- **Date of Election: -** 23.07.23 at 11AM, Sunday at Dr. MGR-Janaki College of Arts and Science for Women

- 7) The signed Nomination form 1/Seconding of Nomination of contestants through Form 2 may be scanned through mobile or by scanner and shall be mailed to the email id election@ cysi.in and the mailing date will be taken as a receipt date. Form 2 may be emailed or WhatsApped to the Contestants by the CySI Members who have seconded their nomination forms 1. In case of any withdrawal the same may be followed. Filled original Nomination form 1 /original Seconding of Nomination form 2 have to be kept safely by the concerned for production on demand by the undersigned and finally to be handed over to the undersigned on 23.07.2023 at Dr. MGR-Janaki College of Arts and Science for Women Adyar on the election day.

- 8) Valid Signed Forms 1 & 2 (attach Photo copy of ID Card or Life membership pay receipt if available) should reach the undersigned email id election@cysi.in not later than Sunday,5 PM on 09.07. 2023.
- 9) Last date for withdrawal of nominations is not later than Thursday,5 PM on 13.07.2023. Request for withdrawal should reach the Election officer by email. All email requests will be taken as a valid document.
- 10) A member can file nomination for one post only. In case any member files for more than one post, he/she has to withdraw the additional nominations to ensure that only one valid nomination comes for scrutiny as on 13.07.2023. If he/she fails to withdraw the second or such other additional nominations before this date, then all nominations from the concerned member will be summarily rejected and such member will be considered as not contesting for any post. All nominations have to be filed under the signature of the member seeking Election and shall be seconded at least by two other members eligible to vote.
- 11) Nominations will be scrutinized by the Election Officer, and the list of valid nominations shall be uploaded in www.cysi.in on 17.07.2023 by the undersigned through Secretary..
- 12) Election wherever necessary (i.e., *where more nominations have been received than the number of posts as declared above*) will be held Dr. MGR- Janaki College of Arts and Science for Women, Adyar on 23.07.2023 at 11AM, Sunday for casting their votes.
- 13) Where the number of nominations received is less than the number of posts or no nomination has been received for any post, the Election Officer can accept floor nomination at the venue and time as stated above and conduct the election as per Bye Law, if necessary, at the venue itself.
- 14) All extant rules and regulations in the byelaws as amended and applicable as on date, especially the Clause No.13 Election Process shall apply.
