## Speech by A.SELVARAJ, Election Officer, CySI Election -2023

## 23.07.2023 – Sunday at Dr.MGR Janaki College, Chennai-28

Ladies and gentlemen, esteemed members of the Cyber Society of India and other fellow citizens,

Good morning and thank you for joining us today as I announce the results of the Cyber Society's election. This has been a momentous occasion, and I am honoured to stand before you as the election officer to share the outcome of this important democratic process.

Firstly, I would like to thank the Outgoing EC Members, who nominated me as the 10<sup>th</sup> Election officer for electing the office Bearers and EC Members of the Cyber Society of India for the financial years 2023 to 2025.

As the nominations filed were not more than the nominations for number of positions declared and called for, I concluded that the contestants have been elected unanimously. I arranged to publish the final contestants on 17.07.2023 and today, the 23<sup>rd</sup> July, 2023, I am declaring the following contestants as elected unopposed for the posts mentioned against their names, for the Executive Committee of CySI for the period 2023-25.
