Extraordinary General Meeting (EGM) Notice - Revised

Date of Previous Meeting: March 16, 2025 (Preponed)

EGM Details:

- Date: Sunday, January 19, 2025
- Time: 10:00 AM to 1:00 PM
- Platform: Zoom (Virtual Meeting)

Background:

The Physical Extraordinary General Meeting (EGM) was originally scheduled for March 16, 2025, at the request of Mr. V. Rajendran. However, after receiving a letter dated 18/12/2024 from Mr. P.Raman, Advocate, containing the signatures of no less than 10% of the current life members, on 25/12/24 the Executive Committee (EC) has carefully reviewed the request and decided to prepone the meeting to an earlier date. The meeting will now be conducted virtually via Zoom.

This decision has been taken with the following objectives in mind:

- Increase Accessibility: Enabling participation from senior citizens, members outside Chennai, and those for whom physical attendance may be difficult.
- Reduce Costs: A virtual meeting eliminates venue rental and other associated costs.
- Enhance Communication: The virtual platform ensures clear guidelines and allows all members an equal opportunity to express their views.
- Support of CySI Byelaw 14: The byelaw permits the use of electronic means for communication, document storage, meeting conduct, and electronic voting in compliance with applicable laws.

Please note:

- In exceptional cases, if a member cannot attend, they must submit a prior notice explaining the reason to the Secretary.

Objectives of the Meeting (As Per Letter 1 Dated 20/11/2024 and 18/12/2024):

- All office bearers, including the current team, have voluntarily committed to the noble cause of raising awareness and educating the general public through CySI's initiatives.
