abandoned by him without stating reasons on 15.04.2025 AN. The programme which was titled:

### Change of Plan:

On **15.04.2025 AN**, the Inspector General/Commissioner of Police conveyed that the event might not be suitable for police personnel, as they already have access to various capacity building opportunities. Accordingly, the focus was shifted to **thgeneral public (netizens)** , for whom awareness and mindset transformation would be more impactful.

### Revised Venue and Audience:

The venue was relocated at short notice to **Sri Aarvee Hotels, 311-A, Bharathiar Road, Siddhapudur, Coimbatore □ 641044**, and the target audience was redefined to include **students, the general public, cyber security enthusiasts and Advocates**

### Chief Guest and Institutional Support:

**Dr. B. Ilango**, aged 87, Former Vice-Chancellor of Bharathiar University, was invited as the **Chief Guest**. Participation was mobilised from **Erode Private Law College and Amrita Vishwa Vidyapeetham**, ensuring meaningful engagement despite the short timeline.

### Community and Volunteer Support:

Several participants with cyber security backgrounds appreciated CySI's initiative to launch a District Chapter in Coimbatore.

Support was extended by civil society organisations such as the **Former Police Officers Trust** and **Voice of the Voiceless**.

Law students **voluntarily managed registration, certificate distribution**, and other logistical responsibilities in a professional manner.

Women volunteers from **Ananya's Nana Nani Homes** contributed significantly by **singing the invocation and National Anthem**, and by **decorating the Kuthu Vilakku** etc.

Several practising **advocates attended and assured their continued support** for CySI's future initiatives.

### Resolutions Passed by the Executive Committee
